8.	Visually check vegetative cover for grass density with no bare spots more than 3 feet in diameter. There should be no woody vegetation or shrubs growing on the Closure cover. 9.	Visually perform a condition check of the survey monitor or benchmarks for damage and visibility.	A



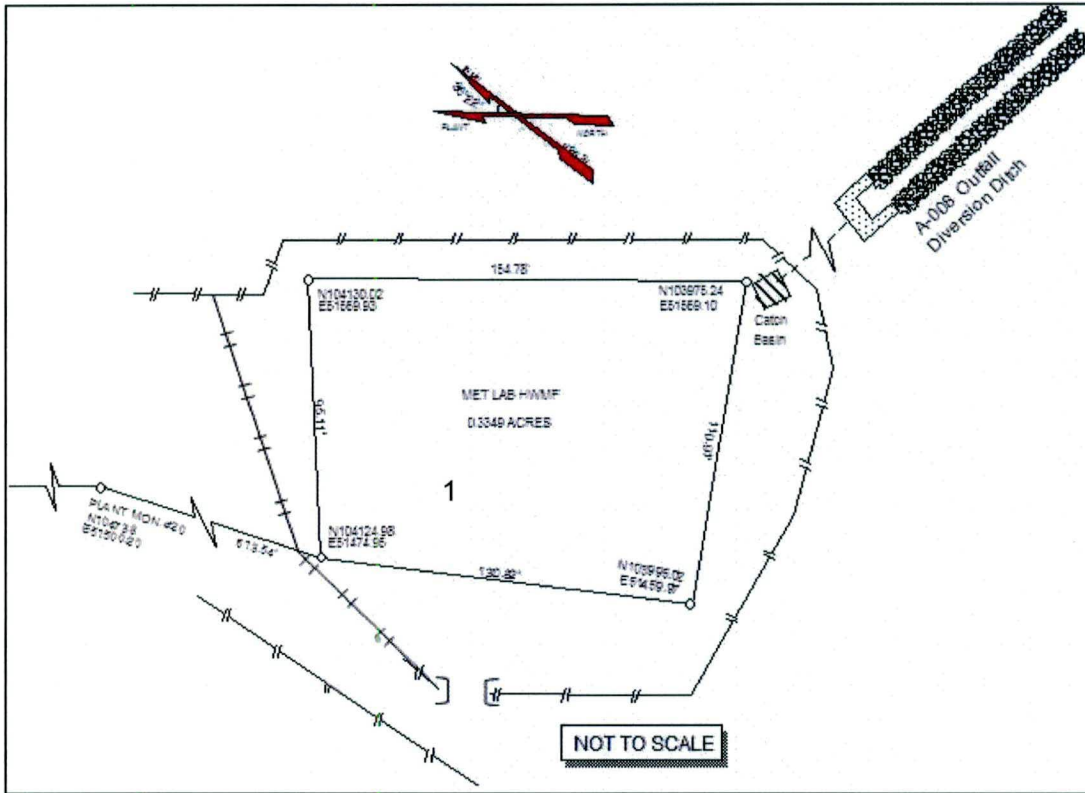

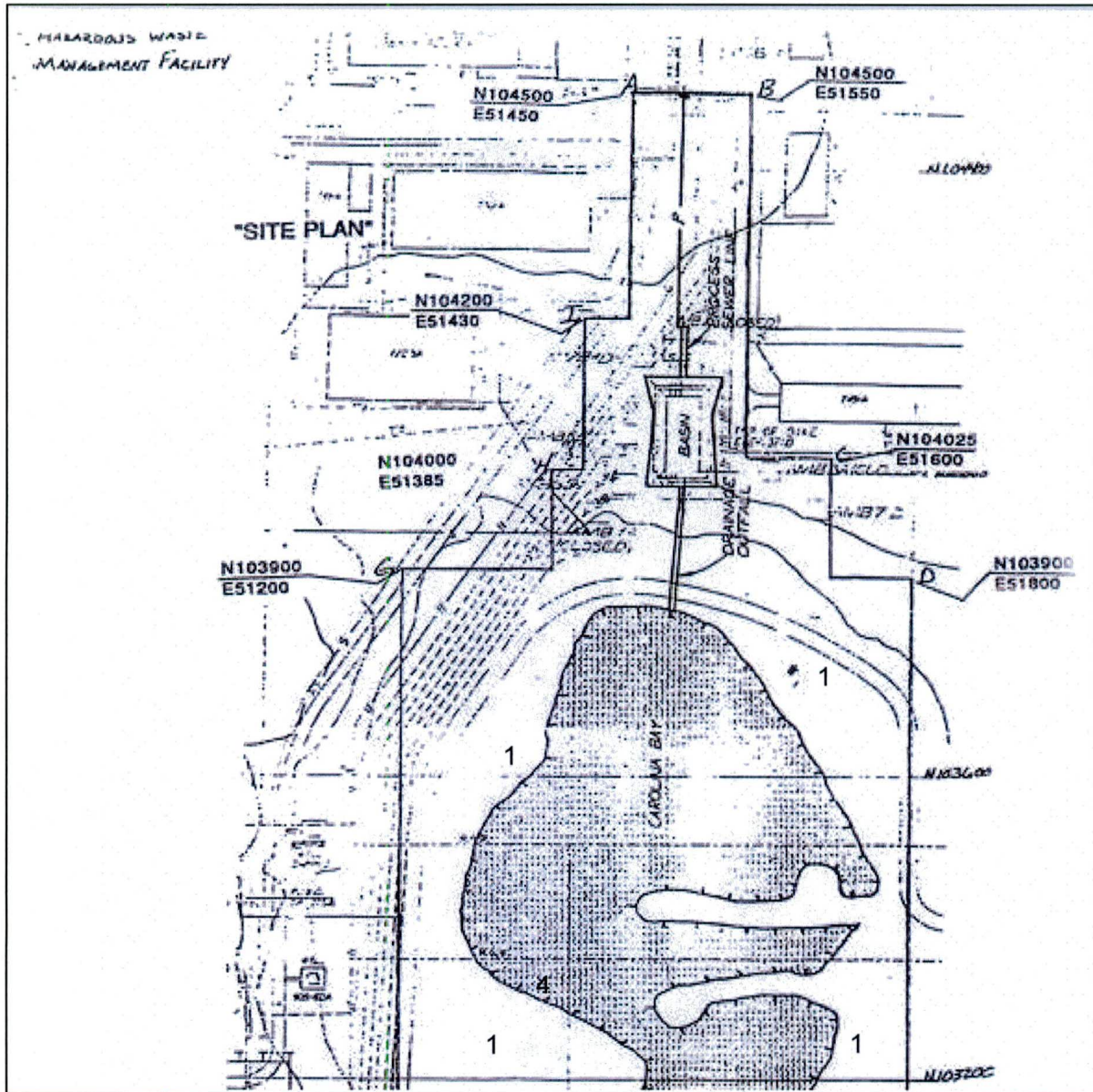
Map of Metallurgical Laboratory HWMF


