## **Industrial Wastewater Closure Module for F-Area Diversion Boxes 5 and 6, F-Area Tank Farm, Savannah River Site**

***Available for Public Comment***

### **Background:**

The U.S. Department of Energy (DOE) Savannah River Operations Office has requested approval from the South Carolina Department of Health and Environmental Control (DHEC) of the Industrial Wastewater Closure Module for F-Area Diversion Boxes 5 and 6, F-Area Tank Farm, Savannah River Site (SRS) to support the removal from service of these ancillary structures. The Consolidated General Closure Plan, approved on May 22, 2017, established the protocols by which DOE would: (1) close SRS F-Area Tank Farm (FTF) and H-Area Tank Farm (HTF) waste tank systems, including ancillary structures, in accordance with South Carolina Regulations R.61-82, "Proper Closeout of Wastewater Treatment Facilities," and R.61-67, "Standards for Wastewater Facility Construction" and other programs; and, (2) obtain approval from DHEC for subsequent waste tank and ancillary structure system-specific closure modules. The subject F Area Diversion Boxes 5 and 6 Closure Module, available for public review and comment, describes the processes by which DOE determined the remaining residual material inventories, evaluated the potential F-Area Diversion Boxes 5 and 6 impact on the FTF performance objectives, and plans for isolation and stabilization of the ancillary structures. The FTF and HTF are managed under Industrial Wastewater Construction Permit #17,424-IW.
