Jon and Susan,

During a review of one of its databases, the U. S. Department of Energy (DOE) realized that Building 242-12F, Radcon Trailer Near 2F Evaporator, is listed in the Federal Facility Agreement Appendix K.1 as a facility to be decommissioned. In 2013, the trailer was damaged due to an air conditioner (A/C) unit fire. The fire was caused by either a mechanical or electrical malfunction with the A/C unit. In 2014, an asbestos inspection report was completed for the facility prior to demolition and the South Carolina Department of Health and Environmental Control issued a demolition permit. Radcon provided survey coverage during the demolition process. Based on the Radcon surveys, demolition began on 7/21/2014 and was completed on 7/23/2014. Since Building 242-12F, Radcon Trailer Near 2F Evaporator, was damaged and demolished due to a fire, the building needs to be removed from Appendix K.1. Additional details of the fire and removal of Building 242-12F, Radcon Trailer Near 2F Evaporator, are provided in the attachment.

The purpose of this email is to submit the attached information for your review and concurrence. Please review the information contained in this email and reply by COB, April 19, 2021 if the proposed path forward for Building 242-12F is acceptable or if a conference call will be required..

Once Savannah River Site receives your concurrence, the Federal Facility Agreement Revision 0 Appendix K for Fiscal Year 2021 will be updated to remove Building 242-12F from Appendix K.1. The email correspondence will be placed in the Administrative Record File as documentation of the agreement.
