In addition to the requirements set forth in the FFA, this document contains the certification for those units utilizing land use controls (LUCs) as a remedy or part of a remedy, as stipulated in the LUC Assurance Plan for the SRS. The LUC certification also includes units with interim remedies that recognize SRS facility security and administrative controls that restrict unauthorized access as long-term protective of human health and the environment. The unit-specific LUCs for these units are deferred until final closure of the units. The effort and time that the U. S. Environmental Protection Agency and South Carolina Department of Health and Environmental Control have given on the subject document are greatly appreciated.
