**SUBMITTAL OF SAVANNAH RIVER SITE INVESTIGATION-DERIVED WASTE MANAGEMENT PLAN, APPENDICES A, B, AND C (WSRC-RP-94-1227, REDLINE REVISION 9E, FEBRUARY 2018)**

The Savannah River Site (SRS) has performed a review of the values listed in Appendices A and B of the approved SRS Investigation-Derived Waste (IDW) Management Plan (WSRC-RP-94-1227, Revision 9, October 2007). Based on this review, the values of the health-based limits (HBLs) for chemicals have been updated. The chemical HBLs were updated to reflect the values found in the November 2017 Environmental Protection Agency's (EPA) Regional Screening Levels. The HBLs for radionuclides reflect the EPA's Preliminary Remediation Goals for Radionuclides, July 2017. These changes were only made to Appendix A - Aqueous IDW and Appendix B - Non-Aqueous IDW. Appendix C - Summary of Changes is included to provide you with a list of the revisions to Appendices A and B. SRS plans to develop a clean copy of the appendices and implement the updated HBLs upon regulatory approval.
